

NUMBER OF LETTINGS PER MONTH




PROJECTS BY PROGRAM AREA

NUMBER OF PROJECTS




PROJECT DOLLARS - 5 YEAR COMPARISON

BY PROGRAM AREA




PERCENT OF PROJECTS

10% OVER ENGINEERS' ESTIMATES BY PROGRAM AREA




LOW BIDS vs. ENGINEERS' ESTIMATES

State Trunkline Projects




STATE PROJECTS vs. ALL BIDS REJECTED Percent ABR Overall


DESIGN OF STATE PROJECTS





Number and Percent




- 751 contracts were awarded in FY 2012 compared to 789 for FY 2011, the difference of 4.8%
- Metro Region area performed the majority of work with less work performed in the UP and the Bay Region areas
- The University and Grand region areas are equal in the number of contracts awarded

- FY 2012, \$923.9 million in contract dollars were awarded compared to \$1.1 billion for FY 2011
- The largest project of \$29.4 million in contract dollars is located in the BAY region

Unbalanced Bid Review Statistics

- Participating program areas: State Trunkline, LAP,
 Freight Services, and Real Estate
- ◆ One-third random selection of projects and projects
 ≥ \$5 million as the engineer's estimate, are reviewed
- During fiscal year 2012, 259 or 36.1%, of the total participating program area projects let were reviewed which represented 53.6% or \$529.0 million, in the total project dollars
- For fiscal year 2011, 257 projects, or 35.3% of projects let, were reviewed which represented \$621.2 million, or 63.4%

Contract Administration Activities

- Electronic Contract Documents Pilot Phase 1
 - MDOT sponsored a pilot letting on September 14, 2012 to introduce a <u>new</u> feature allowing the confirmed low bidder to obtain contract documents electronically through Bid Express
 - Ten projects were included in the pilot letting
 - Benefits provide prompt delivery of the contract documents to the confirmed low bidder and reduced processing fees
 - The feature will potentially reduce the time it takes to award contracts, improving CSD's current performance measurement of ensuring award within 49 days of letting
 - Contractor participants evaluated the merits of this new feature
 - ➤ A positive response was received by all evaluations
 - ➤ This process will be fully implemented for the December 7, 2012, Bid Letting

Contract Administration Activities

- Electronic Contract Documents Pilot Phase 2
 - Within the next fiscal year, MDOT will look at implementing Phase 2
 - Phase 2 will be fully-electronic, including electronic signatures
 - Currently, MDOT is piloting an electronic document submittal feature for construction on the Latson Road contract. The prime is required to submit all required documentation into electronic project files



Contract Administration Activities

- New Prequalification Classification ITS
 - In March of 2012 ITS (Intelligent Transportation Systems) classification was introduced
 - ITS includes but is not limited to: Surveillance, Vehicle Detection, and Traveler Information Systems; Communications and Network Infrastructure; Video Compression Equipment; Road Weather Information Systems (RWIS); Power Systems; and Auxiliary ITS Devices
 - Also included: removal, replacement and reinstallation of the ITS devices
 - Requirements are: Certified Master Electrician on staff, an electrical license for the company, and at least one of the following certified technicians on staff: BICSI Certified ITS Cabling Installer I, IMSA Fiber Optics for ITS Level 2, or ETA Certified Fiber Optic Installer
 - MDOT currently has 7 prequalified ITS contractors
 - 9 projects were let as ITS contracts in FY 2012 with a low bid total of \$14.6 million
